

PARTY REGULATIONS

DEFINITION: A party is 11 or more non-member guests.

1. You must be a Member / Renter in good standing to book a party. **MEMBERS MUST PRESENT FOR THE DURATION OF THE PARTY AND REMAIN WITH GUESTS AT ALL TIMES. If the member hosting the party leaves all guests will be asked to leave.**
2. Party fees are: \$50.00 for 11-25 guests. \$100.00 for 26-40 people (including members).
3. Parties of more than 25 people must get board approval before booking.
 - a. If you feel there is a possibility of more than 25 people, it is advisable to receive prior board approval to avoid any issues the day of your party.
 - b. Fees are doubled for any party with more than 25 people without prior board approval.
 - c. Requested dates may be placed on hold with staff while seeking board approval.
4. Parties must be held in the picnic area.
5. **No parties are allowed before Memorial Day or after Labor Day.** Only one party can be ongoing at any given time on Fridays, Saturdays, and Sundays: **No overlap, no exceptions.**
 - a. Notwithstanding the foregoing, parties may be held after Labor Day with the permission of the LPA Board of Directors.
 - b. Party Fees after Labor Day would be: \$75.00 for 11-25 people. \$150.00 for 26 to 40 people. A clean-up fee of \$100 is also required.
6. No parties may be held on any holiday or holiday weekend. (Memorial Day weekend, Father's Day, July 4 day [or weekend should it fall on such], Labor Day weekend)
7. Party Reservation Forms / Requests must be filled out at least two (2) weeks prior to the party date. Forms and a schedule/calendar are available at the beach. All fees are due when submitting the request.
8. The Beach Manager accepts all reservation requests. This is for your convenience so that you, as a member, can be assured of the date. Contact the Beach Manager who will take care of the reservations.
9. You must be twenty-one (21) years of age and a member to schedule a party. If a party is scheduled for a minor, there must be an adult beach member / parent present at all times. The drinking law will be strictly enforced on our premises.
10. There is a limit of forty (40) people per party – this includes members and direct family. Party Guests are not charged any guest fees. If you are inviting or including other LPA members in your party they must be included in your guest count for your party.
11. Parties must end by 9:00 pm.
12. The beach facility is for private use only. No commercial groups may use the beach; (i.e. swim clubs, parties that charge a "cover charge", nursery schools, day care groups or any club or organizations that charge a fee to use our facilities as part of their activities.)
13. The member hosting may fill one standard ice chest with ice from the ice machine in the Beach Garage. Parties using more than one ice chest will lose party privileges.

14. If the host of a party fails to clean up the area, the host must pay a fee of up to a \$100.00 at the discretion of the LPA Board of Directors
